



How to make a report

This fact sheet tells you how to make a report if you are concerned that a person with disability is at risk of harm.

About us

The Tasmanian Disability Commissioner is an independent authority established on 1 July 2025 under the *Disability Rights, Inclusion and Safeguarding Act 2024* (the Act).

Catherine Whittington is the first Disability Commissioner for Tasmania. The Disability Commissioner uses the Act to make her own decisions without direction from the government.

Disability Commissioner Tasmania refers to the office and staff supporting the Disability Commissioner to deliver the functions under the Act.

We work to protect and promote the rights of people with disability in Tasmania/Lutruwita. We are focused on preventing harm, promoting inclusion, and ensuring people with disability are treated with dignity and respect.

Making a report to us

You can make a report to us if you are concerned that a person with disability may be at risk of harm.

This includes:

- violence
- abuse
- neglect
- coercion
- exploitation.

The report could be about you, someone you know, or something you have witnessed. You can choose to remain anonymous.

A report can help get a problem fixed. People who make reports to us are protected under the *Disability Rights, Inclusion and Safeguarding Act 2024*.

We will listen to you and take your report seriously.

Who can help you make a report?
