



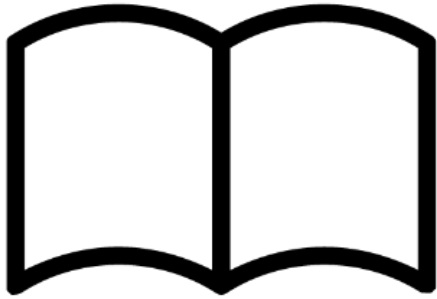

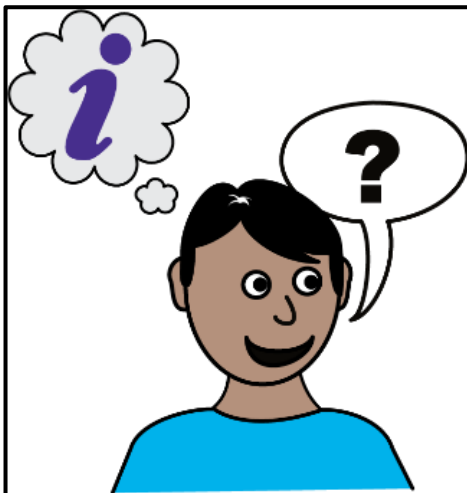

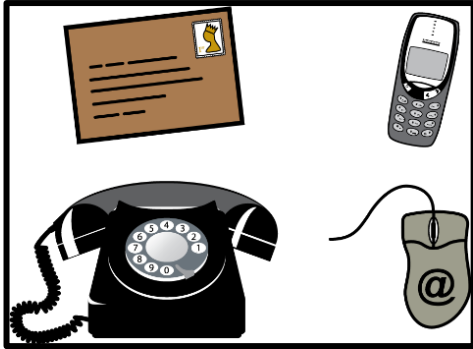

The **Disability Inclusion Advisory Council** will:



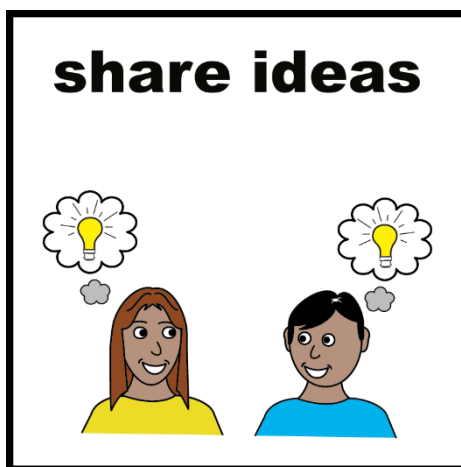
- Give advice on the **Tasmanian Disability Inclusion Plan**. This is the government's plan for inclusion.

- Do some tasks outside meetings.

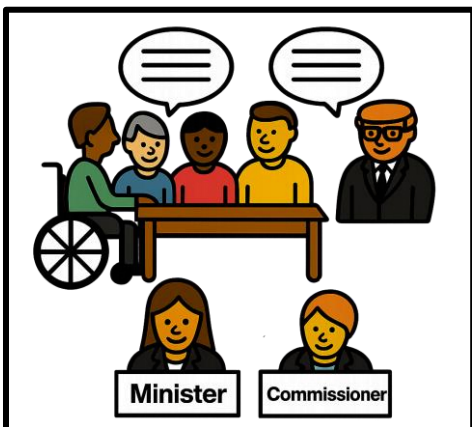

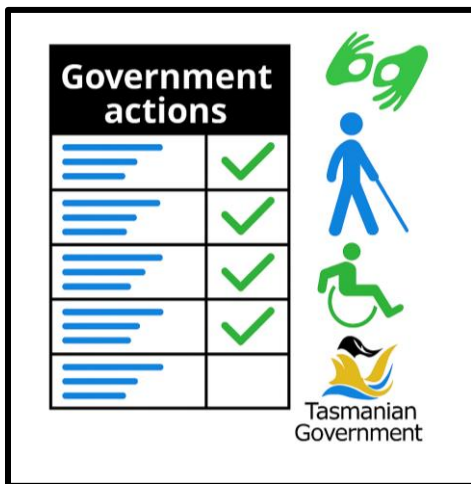


The **Disability Inclusion Advisory Council** is the Council that advises the **Minister** and the **Disability Commissioner**.
